Important Information Regarding Admission of Neet PG-2020 Second Round Counseling FOR PRIVATE MEDICAL/DENTAL COLLEGES.

A. Fresh Allotment This is mandatory for all candidates to first report the nodal center On-line/ Off-line and then report to allotted medical colleges Off-line..

ON-LINE

1. Candidate has to login with his/her roll number and registered email-id to view the allotment result on the website-<https://upneet.gov.in>.
2. Candidate will be provided a button of <pay tuition fee> to submit online tuition fee at the page of allotment result. Candidate has to pay fee of allotted specialty and college.
3. After submitting the tuition fee, candidate will be enabled to download tuition fee receipt .
4. Candidate has to report *on-line* to nodal center through e-mail his/her tuition fee receipts, allotment letter, related documents, and ID to the e-mail-id of the Nodal Center as shown in the allotment letter.
5. Candidate has to report at allotted medical college and submit original documents, receipts, allotment letter and other related documents and complete other formalities in person (*off-line*) and start their duties.

OFF-LINE

1. Candidate has to report to nodal center in person (*off-line*) with his/her allotment letter, related documents, ID and **CTS bank demand draft** of requisite amount of fee in the favor of **DIRECTOR GENERAL MEDICAL EDUCATION AND TRAINING, U.P.** payable at Lucknow.
2. Candidate has to report at allotted medical college and complete other formalities in person (*off-line*) and start their duties.

B. Reshuffled/ Re- Allotment

1. Candidate has to report *on-line* to nodal center through e-mail sending his/her tuition fee receipts, allotment letter, MCI/DCI registration certificate, MBBS/BDS degree, and ID to the e-mail-id of the Nodal Center as shown in the allotment letter.
2. Candidate may report off-line to nodal center with original documents and **CTS bank demand draft** of difference amount of tuition fee in the favor of **DIRECTOR GENERAL MEDICAL EDUCATION AND TRAINING, U.P.** payable at Lucknow.
3. Candidate has to report at allotted medical college and submit original documents, receipts, allotment letter, other related documents, difference of tuition fee and complete other formalities in person (*off-line*) and start their duties.
4. If excess fee paid by candidate in round-1, excess fee will be adjusted in other heads in admitted college/ refunded to candidate.

C. Round -1 admitted candidates

1. Candidate has to report at admitted medical college directly and submit the original documents, fee receipts, allotment letter, other related documents, and complete other formalities in person (*off-line*) and start their duties.

FOR GOVERNMENT MEDICAL/DENTAL COLLEGES.

1. All candidates (Round 1 and 2) have to report at admitted/allotted medical college directly and submit the original documents, fee receipts, allotment letter, other related documents, and complete other formalities in person (*off-line*) and start their duties.
